ORDINANCE NUMBER 4.01 AN ORDINANCE OF THE TOWN OF BLOOMING GROVE REGULATING THE PARKING OF VEHICLES ON STREETS

The Town Board of the Town of Blooming Grove, Dane County, Wisconsin, does ordain as follows:

Section 1.

An Ordinance regulating the parking of vehicles on streets in the Town of Blooming Grove is hereby created.

Section 2.

In the interest of public safety the streets or portions thereof declared to have parking restrictions as set forth in Section 3.

Section 3. Prohibition.

(a) No Parking. No person shall park any vehicle on streets in the Town of Blooming Grove that are posted; or in an area prohibited by the laws of the State of Wisconsin.

(b) Restricted Parking.

- (i) <u>Street Storage Prohibited.</u> No person shall park any vehicle on any street within the Town for 48 or more consecutive hours.
- (ii) Emergency Parking Regulations. The Town Board or person designated by Town Board may regulate the parking and moving of traffic in emergency situations, including street maintenance and snow removal. Such person shall give notice of such parking restrictions by placing appropriate signs in the areas in which such restrictions will be in effect.
- (iii) <u>Snow Emergency.</u> A Snow Emergency is automatically declared when eight (8) inches or more of snow has fallen within a 24-hour period as measured at the Dane County Regional Airport, and automatically ends 24 hours after the accumulation of that snowfall has ended.

During a Snow Emergency no vehicle may be parked on either side of the following streets at any time of the day or night: Alvarez Avenue, Bruns Avenue, Christianson Avenue, Commercial Avenue, N. Fair Oaks Avenue, Furey Avenue, Gannon Avenue, Jacobson Avenue, Memphis Avenue, Powers Avenue, St. Paul Avenue, Thurber Avenue, Webb Avenue, or Worthington Avenue.

- (iv) Alternate Side Parking. Alternate side street parking for snow removal from November 15 to March 15 in Town platted areas only from 1:00 a.m. to 7:00 a.m.
- (v) Moving Illegally Parked Vehicles. The Town Board may remove or cause to be removed any vehicle violating any parking prohibition or restriction of this chapter, to a place where parking is permitted, or to a public parking lot or storage place designated by the Town Board. The owner or operator of such illegally parked vehicle shall, in addition to being liable to a forfeiture as set forth on Exhibit A attached hereto and made a part hereof, be liable for the cost of removal and storage.

Section 4. Penalty for Violation.

The penalty for violation for any provision of this Ordinance shall be a forfeiture as hereinafter provided in secs. 345.20 to 345.53 Wis. Stats. The forfeiture for a violation of any provision of this Ordinance shall not be less than \$50.00.

Section 5. Enforcement.

This Ordinance shall be enforced in accordance with the provisions of secs. 345.20 to 345.53, Chapter 299, and sec. 66.12, Wis. Stats.

Section 6. Effective Date.

This Ordinance shall take effect the day after its passage and publication.
